WCLA Endorsement Policy, 2004

WCLA's endorsements are determined case by case. To be considered for endorsement, candidates must return WCLA's questionnaire and participate in an interview if requested

Incumbents shall be endorsed over pro-choice challengers if they have consistent voting records and have established a reputation for strong leadership and extra effort in advancing access to abortion and contraception. Non-incumbents will be endorsed if they have demonstrated leadership in the community on the issue.

- To be considered for endorsement, candidates must unequivocally support:

  access to abortion and contraception for all women, unimpeded by laws, restrictions,

  - strict confidentiality for all reproductive health care; coverage by public and private insurance of abortion and contraception.

Judicial candidates: To be eligible for endorsement, judicial candidates must participate in an interview if requested by WCLA, and neither seek nor accept the Right to Life Party nomination.



# Senate District 34 Jeff Klein – A Must Win for Choice

The 34<sup>th</sup> Senate District presents an absolutely clear choice for pro-choice voters. **Assemblyman Jeff Klein** has an unequivocal record supporting a woman's right to choose. Kaufman's anti-choice voting record in the State Assembly shows that he wants to criminalize certain safe abortion procedures and put government squarely between women and their doctors.

A win by Jeff Klein is of paramount importance for the 34<sup>th</sup> SD and all residents of New York State. This victory for choice will bring us one step closer to a pro-choice New York

# A Wake-Up Call

If we don't suppress the Detroit vote, we're going to have a tough time in this election." Michigan's Republican



state legislator John Pappageorge uttered those words just a few weeks ago. He was, it seems, referring to the black vote. But, as a subsequent telephone conversation with *New York Times* editorialist Bob Herbert made clear, all groups—women, Hispanics, whoever—that tend to vote Democratic are fair game.

This is 2004, not 1904. Why aren't people outraged and demanding Pappageorge's resignation? Perhaps we're no longer surprised. He gave voice to what many feel has become the modus operandi for winning elections. In recent years, old fashioned voter intimidation has come back in style, e.g. Florida's recent biased voter felon list; students in Texas threatened with arrest for voting where they attend university; minority names simply vanishing from the voter rolls. Now we have electronic voting machines with no paper trail.

Every year, since I was 18, I have voted. Since I have had children, my husband and I have taken first one, then two, and now all three to vote with us. We want our children to feel a sense of responsibility to their country and to themselves. As African-Americans, they know that their forefathers and mothers died for this right; as grandchil-

dren of Holocaust survivors, they know that you can never afford to sit idly by as someone else decides your fate; as children of a family with a diverse religious background, they know that no faith trumps another on Election Day.

They, like I, watch with fascination as masses of people are registering to vote. My kids are convinced that the election is in the bag—"Kerry is sure to win," they say, and add with conviction, "Look at all those new voters."

I don't want to burst their bubble, but if there's one thing WCLA has taught me, a voter is not a voter until s/he pulls the lever. All those new registrants are nothing without a good dose of behavior modification. Just as a smoker needs to be taught not to light up and a dieter not to take that extra bite, a voter needs to be taught to go to the polls. That's something that we at WCLA do very well; by constantly staying in touch, we actively encourage people throughout the year to make their voices heard on Election Day. Our people (you) turn out!

Most likely those new registrants are not part of that highly coveted 2004 election population—the undecided voter in the swing state. That voter baffles the mind! How can anyone be undecided at this point? The two candidates have completely different positions on just about every issue. Bush's positions are clear. He is in favor of: criminalizing abortion, prohibiting stem cell research, and passing a constitutional amendment banning gay marriage; he wants to drill in Alaska; privatize health care, refuse insurance coverage for women's birth control, and give tax breaks to benefit the very wealthy. Simply put, John Kerry isn't.

Kerry is an advocate of civil rights, women's reproductive rights, environmental protection, affordable health care, separation of church and state, and telling the truth.

In the end, the undecided voters will only have as much power as we give them. For every single one of the new registrants that goes to the polls, the weight of an undecided decreases.

My family has decided to watch the debates together. As of press time, we've made it through three, with one more to go. Each of us has our own reason for watching; our 11-year-old has the most concrete—it's the homework assignment. Our daughter on the other hand is already well on her way to becoming a politico, while our five-year-old just likes family time; and my husband and I...well, we believe that the good times are yet to come, and we're going to be there for every step along the way.

After all, as Michael Douglas said in the movie *Wall Street*, "This is your wake-up call." I hope America is listening.

## What's at Stake on Nov. 2? EVERYTHING!

# A Short History Lesson on the Privilege of Voting

The women were innocent and defenseless. And by the end of the night, they were barely alive. Forty prison guards wielding clubs and their warden's blessing went on a rampage against the 33 women wrongly convicted of 'obstructing sidewalk traffic.'

They beat Lucy Burn, chained her hands to the cell bars above her head and left her hanging for the night, bleeding and gasping for air. They hurled Dora Lewis into a dark cell, smashed her head against an iron bed and knocked her out cold. Her cellmate, Alice Cosu, thought Lewis was dead and suffered a heart attack. Additional affidavits describe the guards grabbing, dragging, beating, choking, slamming, pinching, twisting and kicking the women.

Thus unfolded the 'Night of Terror' on Nov. 15, 1917, when the warden at the Occoquan Workhouse in Virginia ordered his guards to teach a lesson to the suffragists imprisoned there because they dared to picket Woodrow Wilson's White House for the right to vote.

For weeks, the women's only water came from an open pail. Their food – all of it colorless slop – was infested with worms. When one of the leaders, Alice

Paul, embarked on a hunger strike, they tied her to a chair, forced a tube down her throat and poured liquid into her until she vomited. She was tortured like this for weeks until word was smuggled out to the press.

So, refresh my memory. Some women won't vote this year because – why, exactly? We have carpool duties? We have to get to work? Our vote doesn't matter? It's raining?

Last week, I went to a sparsely attended screening of HBO's new movie "Iron Jawed Angels." It is a graphic depiction of the battle these women waged so that I could pull the curtain at the polling booth and have my say. I am ashamed to say I needed the reminder.

My friend Wendy, who is my age and studied women's history, saw the HBO movie, too. When she stopped by my desk to talk about it, she looked angry. She was — with herself. "One thought kept coming back to me as I watched that movie," she said. "What would those women think of the way I use — or don't use — my right to vote?" The right to vote, she said, had become valuable to her 'all over again.'

in pulling votes away from Kerry, and, perhaps, provoke the same result as he did in 2000? Apparently not! So one asks, "How is he doing it? How can one man raise the money, carry petitions in each state, and fight the legal battles, especially after the debacle of 2000?"

The answer is simple: with help from the Republican Party. The GOP has rushed to his aid and political reformer Ralph Nader has been very willing to accept their dubious charity.

#### Show me the money

A significant percentage ". . . of Nader's contributors who have given him at least \$250 each have a history of supporting the Republican President, national GOP candidates or the party," reported *The Dallas Morning News* last March. According to The San Francisco Chronicle in July, "Nearly one in ten of Nader's major donors—those writing checks of \$1000 or more—have given in recent months to the Bush-Cheney campaign." Some notable Republicans are among Nader's newest contributors: Jeno and Lois Paulucci, the frozen food magnates, have contributed over \$150,000 to GOP causes since 2000; Jack and Laura Dangermond, operators of ESRI, who recently donated \$40,000 to Republican causes; and Michigan developer Ghassan Saab who has given \$30,000 to the RNC since 2001. Nader has also received more than \$20,000 in "bundled" money, a type of contribution that he had previously denounced.

#### Armey's army

Republicans have openly acknowledged that many of their members are making donations to Nader as a means to help George W, particularly in swing states. Hoover Institute research fellow and veteran GOP strategist Bill Whalen explained, "Republicans have no problem with it, if the goal is to keep President Bush in office." He continued, "...you absolutely want your activists to get out there and help Ralph run . . ." because of his effect on the 2000 election. His third party candidacy successfully drew more votes from the Democratic Party, thereby helping the Republicans win.

And the Bush activists have done just that. Nader's petition drives to get on the ballot in key battleground states like Oregon, Michigan, and Florida have relied on the necessary boost from conservative groups. The Oregon Family Council, a conservative anti-choice anti-gay group, and Citizens for a Sound Economy, an anti-tax group led by Republican Dick Armey, made no attempts to hide the fact that they are trying to keep Kerry out of the White House by helping Nader, says *The Washington Times*. Both groups telephoned Oregonians and urged them to attend a Nader rally geared towards getting the required one thousand registered voters to sign the petition needed to get Nader on the ballot. After Oregon, Dick Armey's troops issued a press release committing themselves to helping Nader "in key battleground states like Wisconsin, Florida, Michigan, Pennsylvania, and

elsewhere."

In Michigan, when Nader's own volunteers only collected 5,400 signatures, about 25,000 less than needed to be placed on the Michigan ballot, the Republican cavalry came to the rescue and collected an additional 43,000, according to the AP.

AlterNet reports that in New Mexico, JSM Inc., a Florida-based marketing firm with known Republican ties, flew petitioners in from out of state, housed them in local hotels and paid between \$1 and \$3 per signature. According to a KUNM news report, the petitioners interviewed believe they were working for the Republican Party. They did not, however, disclose that information to the public unless asked. JSM was also involved in the petition drive in Nevada.

#### Familiar faces

Regarding Nader's legal matters, high profile Republican lawyers have been more than willing to lend a hand. For example, after a Florida judge barred Nader's name from appearing on the ballot, Ken Sukhia, an attorney with strong ties to President Bush, having worked on behalf of the GOP in the 2000 Florida recount, joined the campaign and agreed to represent Nader to fight the ruling.

Apparently, Sukhia was successful because as of September 17th, the Florida Supreme Court rendered the final decision and Nader secured a position on the ballot. As reported in *The New York Times*, Scott Maddox, Chairman of the Florida Democratic Party, said "This case will serve to further illuminate the fact that Ralph Nader is a tool of the Republican Party," and continued that "Glenda Hood and Jeb Bush did everything in their power to get Ralph Nader on the ballot." Maddox further asserted that Secretary of State Glenda Hood is an appointee of Governor Jeb Bush, George W's brother, and has used her office, similar to that of her predecessor, Katherine Harris, as a means of promoting the Republican Presidential nominee.

As of September 18<sup>th</sup>, Ralph Nader is on the ballot in 27 states, thanks to the hard work of the GOP. He could appear on as many as 13 more, pending the outcome of litigation.

As of October 8<sup>th</sup>, friends of the Swift Boat Veterans have contributed thousands of dollars to Nader.

Please don't be fooled. As GOP strategist, Bill Whalen says, "do the math." A vote for Nader is equal to a vote for Bush.

Senate. His opponents Fleming and Kaufman will side with the anti-choice majority of the Bruno-controlled NYS Senate. Jeff Klein will promote women's reproductive rights and will fight for us, the pro-choice majority.

# **Electing Judges: Pro-Choice vs. No-Choice**

Unlike those running for political office, candidates for judge are limited in terms of offering opinions on disputed legal and political issues. In its judicial endorsement process, WCLA sends no questionnaires, but does discuss with candidates their general philosophies regarding pregnant women and the law. To qualify for consideration by WCLA, candidates must agree to an interview and eschew the Right to Life Party.

This year, there are six open seats for the State Supreme Court (14-year term) in the Ninth Judicial District, which includes Westchester, Putnam, Dutchess, Rockland, and Orange Counties, and two open seats for Westchester County Court (10-year term).

WCLA endorses the following Democrats (6) and Republicans (1) for NYS Supreme Court:

County Court Judge Les Adler (D) who has served as a Westchester County Court Judge since 2000; prior to that, he was an Assistant District Attorney, a criminal defense attorney, and a Greenburgh Councilman for 17 years; Supreme Court Justice Joan Lefkowitz (D) who has served as a Supreme Court Justice since 1991, and served as a Family Court Judge prior to that; Acting Supreme Court Justice Bruce Tolbert (D) who has served on the bench for the last

20 years, in both Family and Supreme Court; Acting Supreme Court Justice Al Weiner (D) who has served on the bench for the past 40 years, in Family Court and as Rockland County Surrogate; Judge William Giacomo (D) who was a former Port Chester Town Justice and law clerk to Superior Court judges in Connecticut; Attorney Kevin Griffin (D) who was an Assistant District Attorney in the Bronx, a lawyer in the Westchester County Attorney's office, and has been in private practice for the past 7 years; and Supreme Court Justice Howard Miller (R) who served as a Supreme Court Justice in the Ninth District before becoming an Associate Justice in the Appellate Division Second Department in 1991.

WCLA endorses the following Democrats (2) and Republicans (1) for Westchester County Court:

Attorney Gerald E. Loehr (D) who was an Assistant District Attorney for NY County, a former Yonkers Mayor and a Yonkers City Councilman; Judge Francis Nicolai (D) who is a Supreme Court Justice and the Administrative Judge of the 9<sup>th</sup> Judicial District, and has also served as a County Court Judge; Judge Irene Ratner (R) who served as a County Court Judge in 2002 and is Court Attorney-Referee to Family Court Superviser Joan Cooney.

# RTL Rears Its Ugly Head

The Right to Life Party is back – at least in the 5 counties representing the 9<sup>th</sup> Judicial District.

Despite the fact that the Right to Life Party (RTL) was dropped from the ballot after the last gubernatorial election\*, two candidates for County Court Judge and six candidates for Supreme Court Justice are so committed to denying women control of their own bodies that they collected over 3,500 signatures in an attempt to resurrect the RTL line.

Their commitment to an anti-choice position goes well beyond anything seen in recent memory in New York State. In-

stead of joining an existing party that reflected their beliefs, they went out of their way to recreate a platform from which to espouse their anti-choice position. Their actions warrant judicial review.

BEWARE: Five of the eight candidates—Joseph Alessandro, Matthew Byrne, Joseph Cerreto, Robert Neary and Stuart Rosenwasser—are also running on the Republican and Conservative lines!

Because of a restriction in NYS election law, these five candidates are forbidden to appear on the Republican Party line and a non-established line. Thus, they found a solution: they are taking the Conservative line which will now read Conservative and RTL, and the symbol of the RTL Party, a picture of a fetus, will be placed next to it!

The possibility that any of these eight candidates might be elected should instill fear in all of us!

\*To retain a place automatically on the ballot, a party must receive, at a minimum, 50,000 votes in a gubernatorial election year. The Green Party and the Right to Life Party both failed to reach that minimum in the 2002 election.

**Every time you consider not voting, remember these words:** 

"I am outraged that [the abortion issue] is viewed from the perspective of the woman—a femme-centric perspective that condones the self-indulgent conduct of the woman who was damn careless in the first place." These words were spoken by an elected official, Dick Armey, former U.S. Majority Leader (R-Texas).

What does your elected representative say, and how does s/he vote?

"I will do everything in my power to restrict abortion." These words were spoken by the present President of United States, George W. Bush.

Your vote can stop him from saying it again as an elected official.

## Women's Votes Matter

By Rep. Nita Lowey As I write, the first debate between President Bush and Senator Kerry has taken place, and the race is tightening by the minute. I am certain that this election will go down to the wire, and that we need every pro-choice voter at the polls — the future of our country could truly be riding on one vote.



Like you, I feel America is at a crossroads. This November, Americans will

make a fundamental decision about our character, values, and priorities. We have a chance to stop the extremists in the Republican Party from using our government to push through a far-reaching and radical agenda.

The stakes are so high, especially for those of us who support a woman's right to choose, expanded family planning access, responsible sexuality education, and stronger STD and HIV prevention strategies.

I don't have to tell you that women's health priorities have taken a battering. The U.S. reneged on its commitment to fund family planning programs overseas, even in war-torn areas. President Bush signed the first-ever ban on abortion procedures, without any exception for a woman's health, knowing full well the ban was unconstitutional. The Ashcroft Justice Department unsuccessfully attempted to subpoena women's private medical records from hospitals and Planned Parenthoods, arguing women didn't have the right to confidentiality when they had abortions. The Food and Drug Administration rejected a proposal to allow the Plan B emergency contraceptive to be sold over-the-counter, overriding the overwhelming recommendation of two scientific advisory committees. And the Administration's record of appointments to the federal bench demonstrates the most pronounced ideological tilt in modern history.

As the campaign heated up this summer, the Bush campaign had the nerve to launch an ad campaign aimed at securing women's votes called "W Stands for Women". That's an outrage. "W" does stand for a lot of things, not for women's rights! George W. Bush has waged an all-out war on women's rights and health ever since he took office.

We need a pro-choice President and Congress that will lift the Global Gag Rule, which for four years has dramatically limited our effort to keep women healthy overseas; provide healthy increases to the Title X family planning program, which is being starved deliberately by the Bush Administration; pass a law that creates a strong, responsible sexuality education program for our nation's kids, and stop in its tracks the rush to fund unproven abstinence only until marriage education programs. We need a pro-choice President and Congress to protect and defend Roe v. Wade, to pass contraceptive coverage in all health insurance plans.

22 million single women did not vote in the last election. Don't you dare let that happen again! Our country, our future, our lives are at stake.

# **Lest We Forget**

From 1965 until 1973 when the law changed, <u>JANE</u> was a Chicago based abortion counseling service that not only provided advice, but eventually trained women to perform abortions on over 10,000 women who were in need.

In 1965, after returning from work in the civil rights movement Mississippi Summer Project, Heather Booth was approached by a friend who asked if she could find someone to perform an abortion. The contact was made; the abortion was successful. Word spread. A short time later someone else asked for help. Then another. Then another. By 1968, Heather recruited a group of women to provide the counseling, raise funds and provide support. By 1969, some of the women took control of the process and starting performing the procedure themselves. Women from every part of society—by race, education, income and age—came through JANE. Some were college students. Some were from the poor communities. Some were wives of Chicago policemen. Many were from other states. The quality and care of the Service were (and are) unsurpassed even in these days of legalization.

It was a valiant effort that felt like just doing what needed to be done. It was often terrifying, usually exhausting and deeply affecting all who were involved. There is now a book about this experience called <u>The Story of JANE</u>, the legendary underground feminist abortion service, by Laura Kaplan. There is a movie documentary that is now on video that played on some PBS stations about this, called "JANE: an abortion service." May we celebrate their work, but never have to relive those days again.
